Terms and Conditions:

- Registration Fee is a non-refundable deposit paid at the time of procuring admission.
- To confirm admission, registration fee along with one quarter's fee must be paid.
- Once the term has started the fee for the term is non-refundable. In case of withdrawal of admission, the same must be communicated prior to the commencement of the term.
- Cheques for all quarters must be handed over at the time of Admission and Registration
- Application forms & documents should be submitted as prescribed in the Admission Form.
- Student Kit and all materials required for the term are included in the above stated fee.
- Any cheque bounced / returned would attract a standard penalty of INR 1000, in addition to late payment fee of INR 500 per week.
- Fees are payable for physical school or home-schooling, depending upon the guidelines prescribed by the State Government. School Management will be the final authority in the same.
- In case of children with special needs, developmental delays or having individual needs based on their development, the school must be informed at the time of admission, to ensure the school can work in best interest of the child. The school will act in full support with the parent.
